Attached is OPC staff recommendations to the crab task force. We can live with most of the nominations, except the crab processing interest, these two processors buy from a very small portion of the fleet. In reading Paul Johnson's Bio. I see that he buys 50,000 pounds of crab a year, I would like to point out that the 5 year mean average in most ports for a "single" vessel in the crab fishery is around 50,000, in some ports more. What this means he comes to the table representing "ONE VESSEL".

I know that this is a grey area in the bill, but having served on the crab steering committee this was not the intent of the committee or the bill. The intent of the committee was to see that processors that buy from the largest portion of the fleet are represented. Maybe the processors should vote for their rep. like the fishermen did.

After a few phone calls and some internet work it looks like these two recommendations would better serve the Packard group than the processing sector.

In closing we feel that the needs of the industry would be better served by Joe Caito.

After reviewing the selections for the Crab task force I am quite concerned with the processor representatives. It appears both representatives are representing the Packard foundation and the smallest of buyers. While I am a supporter of small buyers and most of my catch goes to small buyers, the larger processors must be represented on the committee since they are the only ones capable of processing all of Californias commercial crab catch.

Of equal concern is both Bill Carvalho's and Paul Johnson's ties to the Packard foundation. As I'm sure you're aware The Packard foundation is funding the MLPA process and has a vastly different view of commercial fisheries than the fishing community. After being briefed on Paul Johnsons biography I don't believe he can adequately represent the needs of the Dungeness crab fishery and that a representative from one of the larger processors such as Joe Caito or the Pacific group would better serve the Task Force.

Rachelle,

I am writing to express my concerns with the selection of Paul Johnson for one of the processor seats on the Dungeness Crab Task Force. Although I do not know Mr. Johnson personally, and do not doubt his vested interest and knowledge of the crab industry, and do not believe him to be a viable candidate to represent processing and brokering interests for the California dungeness crab industry. It is stated in Mr. Johnson's bio that he buys about 50,000 lbs of crab per year. This is an extremely small amount relative to the estimated 8 million pounds annually caught on average in the state of California. Mr. Johnson deals almost entirely with live crab. I believe that with the selection of Bill Carvalho, this segment of the crab market will be well represented. In fact, I believe Mr. Carvalho had no crabs cooked in the 2008/2009 season meaning 100% of the crab Mr. Carvalho bought this year went to the live market.

An extremely large portion (I'm sure the majority) of crab caught in the state of California goes to the whole cooked and section markets. The selection of these 2 processors leaves and huge void on the task force. We simply need the input and view points of a processor that deals more exclusively with the whole cooked and section market. I believe that Joe Caito would be a much more qualified candidate to fill this seat on the Task Force.

At every level of fisheries management NGO's have become embedded in the process and with the unlimited resources they have, in some venues (MLPA'S) are the primary source of funding. This tends to direct the out comes in favor of their agenda rather than the public or fishing communities interest.

At the federal level the Pacific Fishery Management Council is at times stifled in what is best for the industry because of frivolous lawsuits threatened or real by these groups.

And now, the DCTF has a processor whose company is heavily financed by Packard and another who actually buys very little product and if my information is correct does very little or no processing of crab. It would seem prudent to have one of the major processors involved.

Lets get a breath of fresh air and find a facilitator whose achievements has less to do with the environmental community and more with the interest of the user groups being affected by the outcomes of this committee.

The concern I have along with several fishermen in my Assoc. is that Paul Johnson is a poor representative of the processing and marketing of dungeness in California. A large and important part of marketing crab, is in the form of sections and whole cooks and we feel Paul Johnson has a limited if any experience in these markets. We are also concerned that a person who buys 50,000 lbs of crab per year should be considered a processor, not to say he should not be represented in this task force, but to give him the voting power of a processor is wrong.

This letter is written in regard to the appointment of a seafood processor to the Dungeness crab taskforce. As one of the elected commercial fisherman representatives from Eureka and on behalf of those fishermen in my production tier, I encourage you to select Mr. Bill Carvahlo and Mr. Joe Caito to fill the two processor seats on the taskforce. While this recommendation is not in concert with the Ocean Protection Council (OPC) staff suggestion of Mr. Carvahlo and Mr. Paul Johnson, we believe that the inclusion of Mr. Caito will provide a much better balanced and broader experience to the taskforce. Given the fact that the vast majority of commercially harvested crab in California is marketed as processed product, i.e., as shell crab, sectioned crab or as crab meat, Mr. Caito's lifetime of experience in the processing industry will prove invaluable to the taskforce.
