Dear Secretary Laird:

As you know, the California Fish and Game Commission (Commission) adopted marine protected areas (MPAs) in each region of the State's coastal waters between 2007 and 2013, consistent with the Marine Life Protection Act. This resulted in a statewide network of MPAs with global significance and unprecedented local participation. The Commission strongly supports continued investment in comprehensive implementation of the MPA network to advance its intended goals. With this in mind, I am writing to reinforce my support for the draft California Collaborative Approach: Marine Protected Areas Partnership Plan (Partnership Plan).

The Commission recognizes that active public involvement and partnerships are vital to advancing MPAs in California, starting with their initial design, based on scientific guidance and stakeholder proposals, to adopting and implementing the MPA network, including baseline monitoring, public outreach and education, and citizen science and compliance monitoring.

In recognition of the important contribution that partnerships have and will continue to play in effective and sustained MPA implementation, the Commission stands with its agency MPA leadership partners in support of the collaborative approach to MPA implementation. This is expressed in the draft Partnership Plan, currently in a public and tribal review and comment period, and the subject of your workshop on June 10.


