**REGARDING:** Approval of revised Conflict of Interest Code

Requested Action: Approve the revised Conflict of Interest Code (COIC), as accepted by the FPPC

**Background Information:** The law requires that every state agency have a conflict of interest code which identifies all agency officials and employees who make or participate in making governmental decisions. It is legally required that an agency's conflict of interest code reflect the current structure of its organization and properly identify officials who should be filing Statements of Economic Interests (Form 700).

A review of the Ocean Protection Council's (OPC) code revealed that the code is out of date, and does not accurately reflect the physical location of the OPC or staff classifications. The revision corrects these changes and accurately reflects the current organizational structure, as well as makes changes to reporting categories to bring the OPC in line with other Councils, Commissions and Boards.

After Council approval, there will be a 45 day public notice and public comment period, after which the amended code will be submitted to the FPPC for final approval.

### CONFLICT\_OF\_INTEREST CODE FOR THE

### OCEAN PROTECTION COUNCIL

The Political Reform Act (Government Code § 81000, et seq.) requires state and local government agencies to adopt and promulgate conflict\_-of\_-interest codes. The Fair Political Practices Commission has adopted a regulation (2 Cal. Code of Regs. §18730) that contains the terms of a standard conflict\_-of\_-interest code, which can be incorporated by reference in an agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations § 18730 and any amendments duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. This regulation and the attached Appendices, designating officials and employees and establishing disclosure categories, shall constitute the conflict\_-of\_-interest code of the California Ocean Protection Council (Council).

Individuals holding designated positions shall file their statements with the State Coastal Conservancy Natural Resources Agency / Ocean Protection Council, which will make the statements available for public inspection and reproduction. (Gov. Code Sec. 81008.) Upon receipt of the statements of the Council members—and, their alternates, and the Executive Director, the State Coastal Conservancy—Natural Resources Agency / Ocean Protection Council shall make and retain a copy and forward the original to the Fair Political Practices Commission. All other statements will be retained by the State Coastal Conservancy—Natural Resources Agency / Ocean Protection Council.

Elected state officers who serve on the Ocean Protection Council and the Secretary of the Natural Resources Agency, the Secretary of the Environmental Protection Agency, and the Chair of the State Lands Commission are not required to file a statement of economic interests under this conflict of interest code. Elected state officers are excepted from filing under Government Code Section 82019, and the Secretaries and Chair are excepted from filing under Regulation 18730, Section 3.

#### APPENDIX B

### **DISCLOSURE CATEGORIES**

- (1) Persons in Category (1) must disclose:
  - All investments and business positions in a business entity and sources of
    income, including gifts, loans, and travel payments, from entities involved in
    maritime shipping, energy (such as oil and gas), fishing, marine aquaculture,
    scientific research, pharmaceuticals, ocean recreational activities and companies
    that engage in environmental planning, real estate (such as sales, brokerage or
    investment) or construction.
  - Interests in real property in the State of California.
- (2) Persons in Category (2) shall—must\_disclose all investments and business positions in a business entity or income, including gifts, loans, and travel payments, from a source which is of the type that contracts with the Council to provide goods, services, materials or facilities to the Council or receives grants or monies from or through the Council.
- (3) Persons in Category (3) must disclose all investments and business positions in a business entity and sources of income, including gifts, loans, and travel payments, if the business entity or source provides information technology or telecommunications goods, products or services including computer hardware or software companies, computer consultant services, IT training companies, data processing firms and media services.
