Subject: OC Parks - South Orange County Regional Coastal Resilience Strategic Plan

Dear Ms. Kimball and OPC:

This Letter of Commitment is being provided as California Department of Parks and Recreation, Orange Coast District's intent to collaborate with OC Parks to develop a regional coastal resilience strategic plan that will take the next step towards implementing shoreline adaptation along south Orange County coastlines. Many beaches in southern Orange County have chronic erosion problems causing deterioration of the region's coastline. The project will address the long-term expected shoreline retreat and erosion from Dana Point Harbor to San Clemente covering approximately 7 miles of beach shoreline.

Orange Coast District includes two State Beaches within the project region; Doheny State Beach, and San Clemente State Beach. These parks are part of a network that provide refuge for sensitive plants and animals, protect important cultural resources, and host an array of recreational opportunities. It's important for Orange Coast District to protect the shoreline of these parks to support the regional goals of making the coast resilient to rising sea levels and to investigate and utilize appropriate management actions, including beach nourishment, as viable adaption strategies for combating long-term sea level rise. Orange Coast District has initiated a study to determine long-term shoreline management alternatives for Doheny State Beach. The report also includes recommendations for Capistrano Beach, part of the OC Parks network, located just south of Doheny. Capistrano Beach has sustained significant high-tide damage resulting from long-term erosion and storm events.

Orange Coast District is committed to adaptive management of our shoreline resources and we are pleased to collaborate with OC Parks in its development of an overall strategy for shoreline management and implementation of priority projects. We will integrate information gained from the Doheny State Beach and will provide input in the development of the Regional Coastal Resilience Strategic Plan.

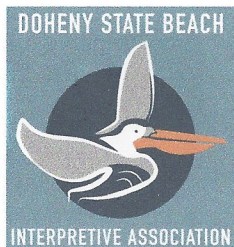

Dear Ms. Kimball and OPC:

Doheny State Beach Interpretive Association (DSBIA) is pleased to support OC Parks in its request for funding from the California Resilience Challenge Grant to address impacts of climate change by drafting resilience strategies along the south Orange County coastline. Doheny State Beach is located on 254 acres of south Orange County beach in Dana Point, California. The County aims to draft a plan that will maintain and restore these beaches impacted by global sea level rise and high tide events. Recent storm events have already limited public access and opportunities for coastal recreation in addition to destroying shoreline habitat.

As erosion progresses and sea levels rise in the area, beach widths are narrowing and may ultimately be obliterated. The beach provides recreational opportunities to the community and supports shorebirds, seabirds, and wading birds by providing natural habitat. Some of these features have recently been lost as a result of high tide events. We are very pleased that this project will generate a plan to maintain and replenish the beaches and provide a more supportive situation for natural features and recreation.

DSBIA, the non-profit cooperating association of Doheny State Beach, was established in 1982 and is one of the oldest cooperating associations in the California State Parks System. It is dedicated to the protection of Doheny State Beach's beaches, facilities, marine refuge, and historical and cultural stories. DSBIA actively supports educational, interpretive, conservation, and restoration programs. We are happy to support OC Parks' efforts to seek funds to conduct technical studies and to draft a resiliency plan for the beaches. We thank you for your consideration of these requests.

The Orange County Transportation Authority (OCTA) is pleased to support OC Parks in their request to seek Proposition 68 grant funding for the coastal resiliency plan. This plan will cover approximately seven miles of beach shoreline in the Dana Point Harbor to the City of San Clemente and facilitates implementation of regional sediment management activities that address chronically eroding shoreline in south Orange County. There have been numerous efforts undertaken or funded by the state to combat the effects of climate change. These studies have revealed potential threats to habitat, public access, beach recreation, and critical infrastructure. OCTA has been actively participating in studies with partner agencies or undertaken our own efforts in planning and building resiliency. Dear Ms. Kimball and OPC:

I am pleased to support OC Parks in its quest for funding from Ocean Protection Council to develop a regional strategic plan for the protection of south Orange County shorelines. This plan will bring us one step closer to mitigating coastal hazards along seven miles of beach that have gone without beach restoration work for years. Due to this lapse, the area has suffered extensive damage from high tides and extreme flooding conditions. Immediate action is needed to guard against further damage from global sea level rise and ongoing high tide events.

Multiple scientific studies have demonstrated that as erosion progresses and sea levels rise, beach widths will narrow and ultimately be washed away. Beaches support shoreline habitat for shorebirds, seabirds, and wading birds. As has been shown in dramatic images published nationwide, over the last two years Capistrano Beach County Park has experienced severe loss of shoreline and public amenities as a result of recent high tide events.

Capo Cares is a volunteer, nonprofit organization whose supporters work tirelessly for the good of Dana Point and its neighborhood of Capistrano ("Capo") Beach.
