ARTS is pleased to support Ocean Protection Council's Coastal Environmental Justice Program for Proposition 1 Grant funding request for the Paradise Creek Wetland Expansion and Park Site project in the City of National City. The project reduces greenhouse gas emissions and improves water quality near Paradise Creek Park and Kimball Elementary, and will increase the gathering area on Paradise Creek Educational Park for the community.

The proposed project will benefit National City residents and visitors by providing safe and connective access to the Paradise Creek Educational Park with the addition of a raised crosswalk on the consistently flooded 18th Street near Paradise Creek. 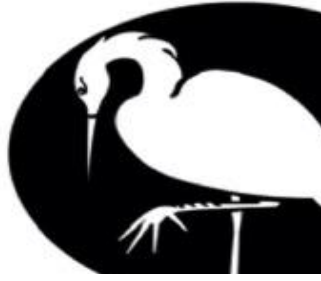
Ocean Connectors has been working with the City of National City in connecting students and residents with its newly constructed Educational Park and we are looking forward to continuing this relationship into the future.
