SUBJECT: Support for Funding to Advance Management of California's Marine Protected Area Network (Item 8) and Advance Climate-Ready Fisheries Management (Item 9)

Dear Secretary Crowfoot,

The Department of Fish and Wildlife (Department) has worked closely with Ocean Protection Council (OPC) staff to develop funding priorities for California's Marine Protected Area (MPA) program and climate ready fisheries management activities and supports the authorization for disbursement of funding for Item 8: To Advance Management of California's Marine Protected Area Network and Item 9: To Advance Climate-Ready Fisheries Management.

In 2023, the Department released the first comprehensive Decadal Management Review of the MPA Network and Management Program that included 28 recommendations prioritizing adaptive management of the Network over the next decade. The proposed funding for **Item 8** will address critical Decadal Management Review recommendations to advance human dimensions monitoring, continue to build on the critical investments to the state's MPA Monitoring Program, and support the nexus between the Department's MPA and fisheries management priorities. The Department's continued partnership with OPC will be integral in moving these recommendations forward.

The proposed funding for **Item 9** will support the pilot testing of electronic fisheries data solutions across several commercial and recreational fisheries. The results of the pilot will be used to modernize California's fisheries data collection programs to streamline reporting for fishermen, better align data collection with management needs, improve accuracy of data, and reduce the time needed to record, transmit, and analyze fisheries data. This will enable the Department to expand its collection of near real-time fisheries data, a crucial element of climate-ready fisheries management.

UC Davis Center for Community and Citizen Science (CCCS) strongly supports the state's ongoing investment in the conservation and management of California's Marine Protected Area (MPA) network, exemplified by the projects under consideration in Agenda Item 8. As a research center dedicated to advancing participatory approaches to scientific research, environmental monitoring, and public engagement with science, we see all of these initiatives as important steps in strengthening California's ocean conservation efforts, and leading the way in community-engaged science.

In particular, we enthusiastically support the allocation of up to \$500,000 to the Resources Legacy Fund (RLF) to expand the MPA Watch network. For more than a decade, the MPA Watch network has built an unparalleled dataset about human activities along the coast, with direct relevance to MPA management questions. On behalf of the undersigned organizations, we express our strong support for the five proposed projects that will further the conservation and management of California's Marine Protected Area (MPA) network. The undersigned organizations—representing the public interest, as well as marine science and environmental justice advocates, and recreational and subsistence fishing interests, are working to ensure California's MPA network is resilient to increasing stressors and that their management is strengthened by science and community engagement. The proposed projects align with the state's commitment to ocean health, climate resilience, and equitable access to marine resources. We request the Ocean Protection Council (OPC) approve the proposed funding allocations for these critical initiatives.

- Continued Ecological Monitoring of Deep Rocky Reef Habitats We support the
 allocation of up to \$1,660,000 to the Marine Applied Research and Exploration (MARE)
 Group and the University of California Santa Barbara (UCSB) for continued ecological
 monitoring of deep rocky reef habitats in the MPA network in 2025 and 2026. This work
 is crucial for understanding the long-term health of these habitats and ensuring
 data-driven management decisions.
- California Collaborative Fisheries Research Program (CCFRP) Monitoring We support up to \$1,380,000 in funding for San Jose State University to continue ecological monitoring in the MPA network in 2026. The CCFRP provides valuable scientific insights through collaboration with local fishing communities, enhancing our ability to assess MPA effectiveness.
- 3. Equitable Access and Benefits from MPAs in a Changing Climate We support up to \$750,000 for the California Marine Sanctuary Foundation (CMSF) to continue research on identifying pathways for equitable access to and benefits from MPAs. Ensuring that MPAs serve all communities, particularly those historically underrepresented, is essential for the long-term success and inclusivity of California's ocean conservation efforts.
- 4. **Expansion of the MPA Watch Program** We strongly endorse the allocation of up to \$500,000 to Resources Legacy Fund (RLF) to expand the MPA Watch program. A better understanding of human use in MPAs and the factors affecting compliance is essential for effective management and enforcement, ultimately ensuring MPAs meet their conservation goals.
- 5. Community Engagement and Empowerment in MPA Management We support up to \$250,000 for the MPA Collaborative Network (MPA CN) to engage and empower underrepresented communities in MPA management policies and processes. Inclusive participation fosters a sense of stewardship and ensures diverse perspectives are considered in decision-making.

Each of these projects represents a critical investment in the future of California's ocean and coastal resources. The continuation of scientific monitoring, research on equity, human use studies, and community engagement will significantly enhance the effectiveness and resilience of our MPA network.

We urge OPC to approve the funding for these five projects and appreciate your ongoing commitment to protecting and sustainably managing California's ocean ecosystems.

Dear Chair Crowfoot and Members of the Ocean Protection Council:

Resources Legacy Fund (RLF) is pleased to submit this letter of support for Item 8 related to marine protected area (MPA) investments and Item 9 related to climate-ready fisheries management on your March 3, 2025 agenda. Both items build upon past state and philanthropic investments and demonstrate the Ocean Protection Council's (OPC) commitment to a healthier and more resilient ocean for all.

Item 8: RLF has served as a long-term partner to OPC and the California Natural Resources Agency to advance MPA implementation. The proposed project "Expansion of the MPA Watch Program" will support the MPA Watch program, which engages more than 200 volunteers per year and has cataloged more than 54,000 surveys of human uses inside and outside of MPAs since 2010. RLF serves as a philanthropic funder and thought partner to the MPA Watch program, and will leverage the proposed OPC funds to support a subset of MPA Watch programs to implement intercept surveys. This data will provide novel insights into MPA visitation and perceptions of MPAs among the public. RLF also supports approval of the other four projects proposed under item 8, which will address critical components of the state's MPA Management Program.

Item 9: RLF has partnered with OPC and the California Department of Fish and Wildlife (CDFW) to advance the state's fisheries technologies and management frameworks for more than a decade. Through the proposed project, RLF will work with OPC, CDFW, and California fishing fleets to modernize data collection to advance climate-ready fisheries management. This project builds on RLF's philanthropic investments in projects such as climate vulnerability analyses, engagement with fishing communities, enhancing CDFW technical capacity, and supporting fishery stakeholder processes. This represents an important opportunity to advance our Memorandum of Understanding with CDFW and OPC, and we look forward to working in close partnership to ensure California's fisheries can meet the climate challenges ahead.



We applaud OPC's forward-thinking approach to ensuring that our ocean and coasts are managed and protected for future generations. Thank you for your consideration of these comments in support of the important investments in Item 8 and Item 9.
